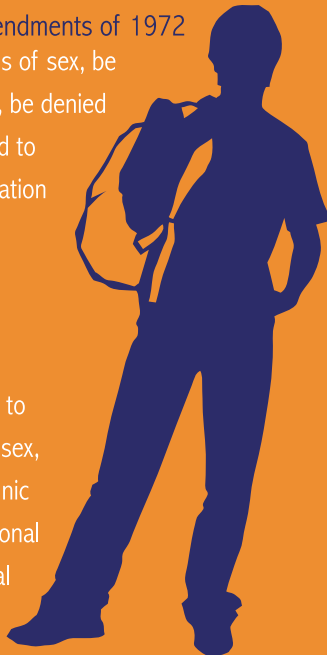

Title IX of the Education Amendments of 1972

"No person...shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance."

Education Code Section 220

"No person shall be subjected to discrimination on the basis of sex, gender, sexual orientation, ethnic group identification, race, national origin, religion, color, or mental or physical disability."



# LAUSD NONDISCRIMINATION STATEMENT

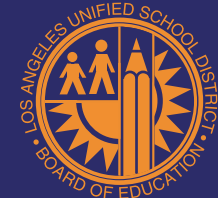

## PROJECT 10 AND LGBT SUPPORT

Project 10 is a District program that offers technical and educational support to schools and students about lesbian, gay, bisexual, and transgender (LGBT) issues.

The following services are provided to students, staff, parents, and community:

- ▼ Information regarding sexual orientation and gender identity.
- ▼ Anti-bias trainings on understanding LGBT youth, as well as recognizing and preventing discrimination, harassment, and bias.
- ▼ Assistance and support in the establishment and maintenance of Project 10/Gay Straight Alliances.
- ▼ Technical support and referral to District and community resources to assist school personnel in addressing LGBT issues.
- ▼ Advocacy on behalf of LGBT students in interactions with District personnel, commissions, task forces, and student, parent, and community groups.

- ▼ Investigation of allegations of discrimination or harassment.

## LGBT STUDENT RIGHTS

LGBT students have the right to equal learning opportunities in their schools.

LGBT students and employees may not be excluded from participation in, be denied the benefits of, or be subjected to harassment or other forms of discrimination on the basis of sex, sexual orientation, or gender identity in any District program or activity.

LGBT students have the right of privacy, including the right to keep their sexual orientation private. It is only with the student's consent that school staff can disclose the student's sexual orientation to others.

LGBT students have the right to participate in all extra-curricular activities, programs, and student clubs, without regard to sexual orientation or gender identity.

LGBT students have the right to attend school in a safe, respectful, supportive, and welcoming environment.



## COMPLAINT PROCESS

- 1 Take your verbal or written complaint to the school administrator or Title IX Complaint Manager within six months from the date the incident occurred. You have the right to a timely and informal resolution at the school site.
- 2 If you are not satisfied with the school site resolution, you may file a written complaint appeal directly with the Local District's Title IX Designee within 15 days of receiving the school site decision. This will begin a formal investigation process that must be completed within 60 days.
- 3 If you are not satisfied with the Local District's response, you may appeal that decision by writing to or calling the District's Title IX Coordinator in the Educational Equity Compliance Office, at (213) 241-7682, or by contacting the California Department of Education, Office of Equal Opportunity, 1430 N. Street, Sacramento, CA 95814.
- 4 Your complaint will be kept as confidential as possible. Retaliation against anyone who files a complaint or participates in a complaint investigation is not permitted.
